1.0 Scope

It is the practice of HWSTS to operate within the designated bus arrival and departure window at every school based on the Hamilton-Wentworth District School Board (HWDSB) and the Hamilton-Wentworth Catholic District School Board (HWCDSB) approved annual school bell times.

As part of the HWSTS commitment to continuous operations improvements, annually during the planning process HWSTS performs quality control reviews on the bus arrival / departure windows for both elementary and secondary schools.

2.0 Responsibility

2.1 The HWSTS Staff are responsible for:

- Maintaining up to date reference tools outlining the partner Board approved bus arrival and departure window criteria
- Ensuring planned student transportation services adhere to partner Board approved bus arrival and departure window criteria
- Liaising with partner Board designated staff in the event of discrepancies / emerging issues
- Communicating directly with parents and other system stakeholders regarding bus arrival and departure window criteria
- Utilizing all available tools, resources and best judgment in a customer centric approach.
- **2.2** The HWSTS Partner Boards are responsible for:
 - Providing HWSTS with the most current, up to date information pertaining to bus arrival and departure window criteria
 - Providing direction to HWSTS for any discrepancies / emerging issues brought forward

3.0 Procedure

3.1 For the Hamilton-Wentworth District School Board (HWDSB):

Secondary schools shall have a 45 minute window for bus arrivals in the morning that shall begin at the entry bell.

Secondary schools shall have a 45 minute window for bus departures in the afternoon that shall begin at the dismissal bell.

Elementary schools shall have a 15 minute window for bus arrivals in the morning that shall begin at the entry bell.

Elementary schools shall have a 15 minute window for bus departures in the afternoon that shall begin at the dismissal bell.

3.2 For the Hamilton-Wentworth Catholic District School Board (HWCDSB):

Secondary schools shall have a 20 minute window for bus arrivals in the morning that shall begin at the entry bell

Secondary schools shall have a 20 minute window for bus departures in the afternoon that shall begin at the dismissal bell.

Elementary schools shall have a 20 minute window for bus arrivals in the morning that shall begin at the entry bell.

Elementary schools shall have a 20 minute window for bus departures in the afternoon that shall begin at the dismissal bell.
